Specifications

INTRODUCTION

Traffic Lights are signaling devices positioned at road intersections, pedestrian crossings, and other locations to control flows of traffic. Traffic light system require a combination of electrical apparatus, hence the need for traffic equipment.

SCOPE OF WORK:

Suppliers are to adhere to the specifications given. Non-adherence to the specifications will result in the quotation not being considered.

REQUIREMENTS OF TRAFFIC CONTROLLERS

The controllers should be microprocessor based and fully electronic and be enclosed in a steel box that is lockable. There must be a lightning arrestor for lightning protection and properly earthed.

Controllers should be upgradeable from 4 phases to 8 phases. Be possible to remove a faulty module on site and replace it, without sending it to the factory. Independent interface modules for quick and easy replacements. Independent fuse-protected lamp outputs and plug in SD memory card for reprogramming.

4-phase traffic light controller with detection. All controller cabinets must be weatherproof and specially designed to deter vandals and theft. Cabinets must all be manufactured from 2 mm, thick hot-dip galvanised steel for strength, and can be powder-coated, for aesthetics and additional corrosion resistance, with a unique mechanical security locking mechanism to provide vandal and theft resistance. The controller must be ideal for cable terminations therefor facilitating trouble shooting and maintenance. Must have built in detectors and pedestrian interface modules.

The supplier should be prepared to give us the software and provide training on maintenance and software of the controllers at no extra cost to the municipality.

Programming of the controllers must be done via laptop or PC via an easy to use configurator and also has a Simulator program. A program should also be able to be loaded on a SD memory card. There should be phase colour LED indicators on the driver module for each aspect. The software should be able to warn the user if the programming has conflicts.
