Introduction

The Sol Plaatje Municipality (SPM) currently operates a hybrid SCCM/Intune environment for managing its endpoints and patch management. To streamline and improve its device management processes, SPM seeks to standardize on Microsoft Intune (for workstations, decommission SCCM, and ensure that all endpoints—both existing and new—are managed through Intune.

The successful service provider will be responsible for onboarding all hybrid managed devices to an Intune-only managed environment, configuring Microsoft Intune to support automated device onboarding, security updates, and vulnerability remediation, as well as providing on-the-job training to the ICT staff.

Objectives of the Project

The objective of this project is to:

- Standardize on Intune for workstation endpoint management, including onboarding of all existing (620) and new devices.
- Automate the onboarding of Windows Defender for all endpoints (620).
