### **Purpose**

Eigenbau is engaged in a refurbishment project at the Riverton Old Works Water Treatment Plant. This project includes an amount of electrical stripping works as explained in the background section below.

Eigenbau wishes to secure and appoint the services of one or more service providers for various portions of electrical stripping works through an expression of interest (EOI).

The selected contractor/s will be appointed over the entire period of the project. The identified electrical stripping works will be allocated to the contractor/s as and when required (Adhoc) through a clearly communicated and detailed work package.

This expression of interest is only available to enterprises that meet the following criteria for being Local, being a Local Emerging Contractor or being a Local Services Provider or Local Supplier and is a Targeted Enterprise as set out below.

#### Local

means the Sol Plaatje Municipality (SPM) area.

#### Local Emerging Contractor

means a legal business entity with its registered office and/or physical address in the Local area.

#### Local Supplier

means a legal business entity with its registered office and/or physical address in the Local area who has actively conducted business in the Local area for a period of more than 12 months and who supplies materials and plant directly to the end-user.

#### Local Services Provider

means a legal business entity with its registered office and physical address in the Local area who has actively conducted business in the Local area for a period of more than 12 months and who supplies services directly to the end-user.

Pre-qualification Criteria for Targeted Enterprises

i. an EME or QSE which is at least 51% owned by black people.

- ii. an EME or QSE which is at least 51% owned by black people who are youth.
- iii. an EME or QSE which is at least 51% owned by black people who are women.
- iv. an EME or QSE which is at least 51% owned by black people with disabilities.
- v. an EME or QSE which is 51% owned by black people living in rural or underdeveloped areas or townships.

## Background

Eigenbau Pty Ltd is a company with a long history of successful projects in the water and wastewater treatment space. As such, Eigenbau competitively tendered for the appointment for various mechanical and electrical works at the Riverton Old Works. Eigenbau were appointed as the sole Main Contractor in the refurbishment of old plant's filters, chlorine and chemical dosing systems at Riverton Water Treatment works.

As part of the scope of works, we are required to strip existing electrical connections on-site. **Schedule 19 – EREM: Removal of Existing Electrical and Electronic Equipment** outlines and provides for the removal and disposal of all electrical equipment to an approved site. The contractor will allocate the approved disposal site to the successful candidate(s).

**Note:** Schedule 19 – EREM is to be used as a guideline to showcase the kind of work to be expected as part of this expression of interest. **DO NOT PRICE THIS SCHEDULE**.

Since this portion of the work will be carried out while the treatment plant remains operational, the appointed contractor must have proven experience in isolating and demarcating live equipment without disrupting the functionality of the rest of the plant

For this reason, Eigenbau will be appointing one or more capable contractors to provide adhoc services over the duration of the contract. This work has been identified as being suitable for subcontracting to a party/ies who can manage tight timeframes for executing electrical works in confined environments. Eigenbau herewith issue this invitation to tender to suitable registered and experienced service providers for this as an expression of interest to qualifying local entities.

NOTE: All responding parties are to remain aware that the main contract was secured under competitive bidding and accordingly the responding parties are encouraged to research what is acceptable rates for such work that allows all parties to reasonably benefit from the work. Eigenbau is committed to sharing workload, within the main contract parameters

#### Site Location

Riverton Water Treatment Works is located 30km north of Kimberly along the Vaal River. The construction site is adjacent to the plants main peripheral fencing close to the main entrance gate. The site is controlled/managed/ secured by Sol Plaatje Municipality and therefore any service provider is required to co-operate with them or their selected service providers/contractors etc and abide by any rules of their site. Access is by road.

## Scope of work

Eigenbau requires the services of a competent and fully registered Contractor/s to provide electrical equipment stripping services.

The Scope of work entails:

- a. Removal of various sized cables ranging from 1.5mm2 to 150mm2.
- b. Removal of Motor Control Centres (MCC).
- c. Removal of small power and lighting distribution boards

- d. Removal of existing cable ladders
- e. Removal of existing conduit
- f. Removal of existing lights

**Note**: The scope of work is not limited to the above listed items. Other minute undefined portions of work may arise in the course of execution. ALL material removed from site will be disposed at a spoil site identified by the contractor. The cost of transportation to the spoil site should be included in each identified work package.

### Site Access

The site can be accessed by road.

## **Assumptions**

No variation orders will be required nor should arise from a developed work package unless otherwise communicated through an formal instruction.

### **Deliverables**

Below are the required deliverables.

- a. Health and safety file in accordance with OSH Act of 1993
- Ensuring that each allocated work package is fully addressed and work is signed off by the site agent.

### Constraints

1. Submission closing date will be on the 07<sup>th</sup> of February 2025.
